Subject: Invitation to Tender – Water Tanks for Nour Shams Camps

Background:

The Palestinian Association for Empowerment and Local Development – REFORM is a Palestinian NGO that works in the fields of empowerment, local development and social transformation. It seeks to promote inclusion and social solidarity in Palestine through empowering marginalized hard-to-reach groups and structural reform. REFORM aims to boost the social and political engagement of marginalized hard-to-reach groups and community activism. It seeks to promote equal access to public utilities by empowering young men and women while establishing a dependable database for political and administrative decision-makers in Palestine.

Deadline: Monday 30.09.2024 at 2:00 pm.

Specifications:

Water tanks for Nour Shams Camp, in collaboration with The Refugee Affairs Department DORA, and OCG.

- The water tank should be designed in a vertical shape.
- It should be a high-quality triple-layer plastic water tank made from polyethylene.
- The tank must comply with health standards, and the material used should not be harmful to human health nor react with water.
- The tank should be white, smooth, and polished, making it resistant to algae and fungi formation.
- The manufacturing material should not be recycled from waste.
- The plastic tank should be made with UV-treated materials to ensure its safety from sunlight and humidity.

Ramallah, Palestine • Its capacity is 1,500 liters and includes a 3/4-inch brass nipple.

Purpose:

Nour Shams Camp has been facing significant water supply challenges. The installation of these water tanks will help alleviate the pressure by ensuring that the camp's residents have access to adequate water storage, particularly during periods of low supply.

General Terms:

- **Location:** (Nour Shams Camp)
- The supplier should have the capacity to provide a total of 89 tanks. Payment will be based on the actual quantity purchased.
- The supplier should have the capability to deliver to West bank.
- In cases where materials are not available from a single provider, it is permissible to consider purchasing from multiple service providers.
- The logos for REFORM, OCG, DORA should be printed on each tank.

Submission Criteria:

- Suppliers who meet the needed specifications and are interested, kindly see the below mentioned requirements for applying.

 - Technical Offer 40%:
 - Specifications of the tank
 - Delivery and available quantity in stock
 - Financial Offer 60%
- The financial offer should be drafted in English and submitted in **ILS** including VAT per tank and total of 80 tanks. All taxes must be included in the final price.
- The financial and technical offers must be submitted in English and signed/or stamped, **in sealed envelopes** and delivered by hand to the following address:
