#### **Wall Mural Artist**

#### **Background:**

The Palestinian Association for Empowerment and Local Development—REFORM is a Palestinian NGO that works in the fields of empowerment, local development and social transformation. It seeks to promote inclusion and social solidarity in Palestine through empowering marginalised hard-to-reach groups and structural reform. REFORM aims to enhance the social and political participation of marginalised hard-to-reach groups and community activism to facilitate equal access to public utilities through strengthening the capabilities of young and women and to provide a reliable database for the political and administrative decision makers in Palestine.

REFORM is looking for a **Wall Mural Artist**. Interested candidates should submit their offers latest by **Monday, 14.08.2023, 3:00 PM**.

#### **Specifications:**

- 3 years proven experience in mural painting: The individual should have a portfolio or examples of their previous mural artwork, showcasing their proficiency and creativity in mural painting.
- Experience in working with different surfaces
- Ability to translate concepts into visual art: The mural painter must be capable of translating complex ideas, messages, or themes into visually compelling and engaging artwork that aligns with the goals of the initiatives.
- Awareness of local culture and context to ensure that the mural's message resonates with the target audience.
- Commitment to deadlines and project management.
- Interest in social and gender issues.

**Purposes:**

- Create and paint two distinct and captivating wall murals as per the project's requirements.
- Ensure that the entire painting process is completed within a period of two weeks from the date of contracting.
- Conduct a meeting with the REFORM team ahead of the event to discuss the mural's concept and specifications.
- Maintain regular communication and coordination with the project team throughout the mural creation process.
- The designated mural locations are Salfit downtown and Salfit at QOU.
- The mural implementation is scheduled for August 2023.
- Following the meeting with REFORM, the artist should provide a sketch within one week, seeking approval on the mural's concept from the organization. The dimensions of each mural will be approximately 2 meters in height and 3 meters in width.

Interested candidates should submit **separate** technical and financial offers in stamped and/ or signed **2 sealed envelopes** latest by **Monday, 14.08.2023, 3:00 PM** at REFORM's office in Ramallah, Al-Masyoun, Al-Tirawi Building, 2nd floor, Telephone 022966646.

- Financial offers must be submitted in ILS **(Including VAT)**.
- A valid deduction at source certificate is required (please attach with the financial offer), or else 10% of the total payment will be deducted as income tax

- **Technical offer which includes:**
- CV/Resume that reflect general contact Information and document your experience and contains Color images of your completed previous Mural work, (Information must include Artist Name, Title of Artwork, Year.
- Number of days you expect to complete it.
- Samples from previous work.

**Price offer which includes:**

- Price offer should be submitted in ILS, and include both your fees, and the materials cost, etc. (effort price and materials/ painting colors cost price)
  - **Note:** We would like the mural to last a long time. Please ensure you select materials that will accomplish this.
- REFORM will refuse any incomplete offers
