Audit Specifications:

- The audit is to be conducted and reported in accordance with International Standard on Auditing (ISAs) by a legally registered auditing firm with international membership.
- The provider shall prepare and submit a comprehensive management letter for the audit period including management's response with each audit. The letter should offer suggestions for improvement in financial management and internal controls.
- According to Si's audit instructions the auditor needs to be connected to the International Federation
 of Accountants (IFAC) and conduct the audit according to the standards of the International Auditing
 and Assurance Standard Board (IAASB).
- As long as local auditors are connected to the federation and following the standards there shouldn't be any reason to not use a local auditor.
- The provider must submit the FINAL drafts to REFORM no later than 20.05.2024.
- Project Duration is 02.05.2022 to 02.05.2024.
- Audit Service will be on payments and procedures.
- One final audit report for the whole period for the project should be delivered.
- An Average of 5 transactions will be added to the journal listing.

Submission criteria:

For those who meet the criteria must submit both a technical and financial offer in English and must be stamped and delivered by hand in sealed envelope to REFORM office.

The offer must include the following:

- Technical Offer: 40%
 - General information and experience of the firm, including responsible staff assigned to the audit.


